Option 1 – includes annual pay updates once valuation data is received for \$4,375.00 Option 2 – includes importing ongoing bi-weekly payroll feeds throughout the year for \$6,250 The one-time implementation fee is \$3,400.00

Trustee Andrew Hill made a motion to approve option 2, which includes importing ongoing bi-weekly feeds throughout the year, and so long as staff works with Foster & Foster before implementing to get the workshop scheduled. Trustee Ty Tolbert seconded the motion. All were in favor, motion carried.
